ONCAT was established in 2011 (as a successor to the College University Consortium Council), with a primary focus on reducing barriers for students interested in transferring between Ontario's publicly assisted colleges and universities.

ONCAT's 2023-26 Strategic Plan broadened the organizational mandate to "help postsecondary learners get where they want to go, no matter where they begin" – spanning the entire education-to-employment journey.





ONCAT is an independent not-for-profit organization, governed according to the ONCAT General Bylaws.

ONCAT is funded by the Government of Ontario.

Oversight is provided by the Ministry of Colleges and Universities and the ONCAT Board, which includes representatives from member institutions and partner organizations.



### **ONCAT's Core Activities**

- Engage stakeholders to improve opportunities for learners to achieve their personal, educational, and professional goals
- Manage ONTransfer.ca, a tool that helps learners navigate their transfer and pathway options
- Provide funding for projects that develop learnercentric policies, practices, and pathways at postsecondary institutions
- Conduct research and analyze data to generate new insights about issues related to learner mobility
- Promote effective practices for supporting the academic and non-academic success of learners

# Funding Opportunities

To encourage activities that improve greater learner mobility, ONCAT supports Ontario's publicly assisted postsecondary sector through two broad categories of funding opportunities:

- Institutional grants for projects that bolster administrative capacity and/or foster productive collaboration
- Research grants for projects that generate new insights about issues related to learner mobility



# Institutional Projects – 2023-24

For the first time in ONCAT's history, the total funding request from all applications exceeded the available budget allocation.

We anticipate that interest in ONCAT funding opportunities for institutional projects will remain high – and possibly even increase – for the 2024-25 year.

The impact of limits on international students adds a degree of unpredictability. Some institutions might pursue new funding sources; other institutions might pause any additional initiatives.

We encourage applicants to consider this context when developing applications for institutional projects.

# 2024-25 Funding Opportunities

### **ONCAT Collaboration Grants**

- Support the development and implementation of learner-centric policies, practices, and pathways across multiple postsecondary institutions or the entire postsecondary sector
- \$25,000-\$100,000 (larger grants may be considered for projects that include five or more postsecondary institutions)
- Applications are due by 4:00 pm on November 21, 2024
  - Applications received after this point will be considered for the next application deadline: February 6, 2025
- NEW for 2024-25, applications related to program pathways and/or articulation agreements are encouraged to support the acquisition of skills and credentials for in-demand jobs in the following sectors: healthcare, marine transportation, advanced manufacturing, electric vehicles, critical minerals, mental health services/accessibility and housing



# **ONCAT Capacity and Collaboration Grants**

### **Focus and Activities**

- Expanding opportunities for learners to move between postsecondary programs and institutions
- Facilitating recognition of prior learning
- Maximizing credit that learners receive for their previous education and experience
- Reducing unnecessary, bureaucratic, or inequitable barriers that impede a learner's ability to pursue their educational and professional goals
- Helping learners achieve greater levels of academic success and personal satisfaction with their postsecondary experiences
- Supporting learners with transitions into the labour market



# 2024-25 Funding Opportunities

### **Indigenous Institutes Transfer Grants**

- Support the development and implementation of learner-centric policies, practices, and pathways at a single Indigenous Institute
- \$25,000-\$75,000
- Institutions can submit an application any time between October 24, 2024, and February 6, 2025



# Indigenous Institutes Transfer Grants

### **Focus and Activities**

Through this collaborative funding opportunity, Indigenous Institutes can work with ONCAT to review the current state of transfer policies, student supports, data collection and reporting processes, pathway opportunities, and engagement with the postsecondary sector.

In addition, the Indigenous Institutes Transfer Grants can bolster operational capacity to implement transfer-related policies, practices, and pathways that will not only support individual learners, but also facilitate greater inclusion of Indigenous Institutes for learner mobility opportunities within Ontario's postsecondary sector.

# Examples from 2023-24

- Improving administrative processes for transfer
- Providing academic and non-academic services for transfer students
- Increasing access to communities that are underrepresented at postsecondary institutions
- Developing curriculum related to transfer
- Expanding PLAR activities

# Developing a Project



# Purpose and Scope

ONCAT grants are intended to support projects with defined timelines and activities.

ONCAT grants are not intended to cover operating budgets for administrative departments and/or ongoing costs for permanent programs.

ONCAT grants cannot be used to support projects that have received (or have applied for) any funding from the Credit Transfer Innovation Grant (CTIG), eCampusOntario, and/or the Higher Education Quality Council of Ontario (HEQCO).

# Defining Elements of a Project

#### Time

Projects have definable start and end dates.

- Projects may build upon the success of previous projects.
- ONCAT may determine that a series of consecutive projects focusing on similar activities is a permanent program (and thus ineligible for ONCAT funding).

Projects have "project milestones" – progress markers that can be identified by the completion of tasks, rather than the passage of time.

- Processing 100 courses is a project milestone.
- Processing courses for 4 months is not a project milestone.



# Defining Elements of a Project

### People

In order to start new projects, institutions typically need to expand their administrative capacity. Many ONCAT-funded projects involve the participation of people who spend the majority of their time working on the project:

- New hires often on limited-term contracts
- Current employees with project funding used for new hires to backfill the current employees' tasks
- External consultants with judicious consideration of costs

ONCAT may determine that people who spend limited time working on the project are covered by the institution's operating budget (and thus ineligible for ONCAT funding).



# Defining Elements of a Project

### **Deliverables**

Projects produce deliverables that can be achieved through progress, rather than duration.

- Creating a PDF resource for transfer students is a deliverable.
- Working on a PDF resource for 12 months is not a deliverable.

NEW for 2024-25, applicants for institutional projects must identify and describe project deliverables using three categories:

- Materials for Institutional Use
- Materials for Public Distribution
- Substantial Accomplishments

# Deliverables

- Substantial Accomplishments

"Materials for Institutional Use" refer to any physical or digital assets that will be produced throughout the course of your project and then circulated within your institution, but not shared with the general public.

Examples of Materials for Institutional Use could include physical or digital assets such as administrative tools, process maps, policy documents, transfer credit databases, pathway/articulation agreements, etc.

"Materials for Public Distribution" refer to any physical or digital assets that will be produced throughout the course of your project and then shared with the general public.

Examples of Materials for Public Distribution could include physical or digital assets such as a brochure promoting pathway opportunities, a website of resources for transfer students, a video series explaining the PLAR application process, etc.

"Substantial Accomplishments" refer to the completion of any significant activities or events that do not result in the production of physical or digital assets.

Examples of Substantial Accomplishments could include significant activities or events such as the offering of a course for transfer students, the digitizing of assessment processes, the analyzing of data related to learner mobility, etc.

Note that all ONCAT-funded institutional projects will submit the following Reporting Requirements:

- Multiple progress reports for ONCAT's internal review
- Evaluation Report that provides feedback about administrative processes for ONCAT's internal review
- Achievement Report that describes project activities ONCAT may publicly share with external stakeholders
- Financial Statements

# **ONCAT Activities**

#### ONTransfer.ca

ONTransfer.ca is a free tool to help students transfer between publicly assisted colleges, universities, and Indigenous Institutes in Ontario.

ONTransfer.ca is maintained by ONCAT and funded by the Government of Ontario.

On a regular basis, most publicly assisted colleges, universities, and Indigenous Institutes in Ontario submit updated transfer and course information to ONCAT.

# Budget

## Budget

Closely review the budget guidelines for information about eligible and ineligible expenses for ONCAT Capacity Grants.

Round each cost to the nearest increment of \$250.

Do not list in-kind expenses; this information complicates the evaluation process.

 Submit a detailed budget for your project, using the Budget Form provided by ONCAT. ONCAT will evaluate the appropriateness of the budget to support the proposed activities.



#### Can ONCAT confirm details about future funding opportunities?

ONCAT is funded by the Government of Ontario. All programs and details are subject to change without notice.

#### Can institutions submit multiple applications?

Yes, institutions can submit multiple applications to ONCAT's 2024-25 funding opportunities for institutional projects.

- An institution could submit a single application to multiple funding streams (ONCAT Capacity Grant AND ONCAT Collaboration Grant).
- An institution could submit multiple applications to a single funding stream (ONCAT Capacity Grant).
- Multiple applications from a single institution must focus on different projects.



#### How does ONCAT evaluate applications for institutional projects?

In fall 2024, ONCAT plans to evaluate applications on the following criteria:

- Clarity: the compelling rationale for the project and the detailed description of the project's activities
- Impact: the potential for the project to create transformative and measurable change for Ontario learners
- Feasibility: the appropriateness of the timeline and budget to support the proposed activities
- Sustainability/Scalability: the viability of maintaining or continuing the outcomes of the project's activities at your institution and/or replicating the project's activities across multiple postsecondary institutions or the entire postsecondary sector

#### Does ONCAT provide full or partial funding to applicants?

In fall 2024, ONCAT plans to evaluate applications in three ways:

- Successful application offer of full funding for the total request
  - Offers for "full" funding will typically range from 90-110% of the total request, based on a review of the proposed budget.
- Successful application offer of partial funding for the total request
  - ONCAT recognizes that offers for partial funding might limit the viability of the proposed project. Applicants may decline the offer and submit a revised application for future funding opportunities.

#### Do we list in-kind expenses?


ONCAT appreciates that many projects involve the institution-wide contribution of resources.

#### How much money should we apply for?

Create a budget that realistically reflects your project's scope.

We do not encourage applicants to submit inflated budgets as a tactic to buffer against offers of partial funding.
