

WHAT IS ONTRANSFER.CA?



BUILDING ON SHARED RESOURCES

NEW HIGH SCHOOL BROCHURE

ONCAT continues to work with students and stakeholders to ensure that there is a better understanding of the transfer and mobility opportunities, outcomes, and progress afforded by our system.

As our stakeholder base expands and shifts, ONCAT strives to proactively respond to evolving needs. After comprehensive research, product development, and feedback, a new High School brochure was released in Fall 2017, in both online and print formats. The brochure is tailored to students in secondary school who are thinking about their next educational steps, and is designed to help explain some of the requirements for College and University studies, with a focus on transfer.

We were thrilled by the response, seeing 14,000+ copies of the brochure ordered in just the first three months of the launch – a clear sign that this resource was a much needed complement to the materials available to students planning their postsecondary path, and those stakeholders supporting them with this task.

ONCAT will continue to welcome feedback to further refine the brochure as needed, and intends to begin work on similar tailored resources for our other audiences, including adult learners. View and order free copies of this resource on the ONCAT website.



PLATFORMS FOR COLLABORATION

In June 2017, Pan-Canadian partners gathered in Toronto for the Pan-Canadian Consortium on Admissions & Transfer (PCCAT) Annual Conference

to discuss related research, promising new initiatives, and successful best practices in credit transfer. Also celebrated at the conference was the expansion of a Memorandum of Understanding (MoU) to enhance student mobility across their jurisdictions and across the country. Seven provincial councils are now signatories, including ONCAT. The long-term goal is to establish a shared database so students

in any jurisdiction can search for post-secondary educational opportunities inter-provincially.

February 2018 marked ONCAT's 4th ONTransfer.ca Day, bringing administrators from 45 colleges and universities across the province to Toronto to discuss the technical aspects of credit transfer, and share tools and resources. Discussions centered on streamlining of transfer processes, credit assessment, and collaboration. A plenary session featured two transfer students who shared their experiences, challenges, and hopes, from which attendees had the opportunity to learn and

brainstorm solutions.

We are also pleased to welcome over 300 participants from all levels of Ontario's PSE community to ONCAT's 7th annual Student Pathways in Higher Education conference. The conference gives participants the opportunity to learn about emerging

directions on transfer and mobility, both provincially and nationally, explore new partnerships, and share credit transfer and student support best practices.



ONTRANSFER.CA AND ONCAT WEBSITES

As ONCAT's flagship service, the ONTransfer.ca website continues to be maintained and developed with the goal of providing students with a central access point for all information on credit transfer in Ontario. In complement to this platform is the ONCAT corporate site. Where ONTransfer.ca services as the hub for students, ONCAT.ca serves as a sector resource for our stakeholders and partners.

As part of our rebranding, and in order to provide a revitalized electronic platform for resourcing and support, a website redevelopment of ONCAT.ca began in 2017.

After the release and review of a project schedule and thorough RFP in May 2017, ONCAT engaged the services of Digital Echidna, a London Ontario based agency. The website is expected to launch in spring of 2018, and will include a new project search feature, and the capacity for hosting expanded resources from our communities of practice, including an online Learning Outcomes toolkit.

MOBILITY INFRASTRUCTURE



Reliable information, and collaboration in the improvement of new and existing pathways, is crucial to ensuring successful and effective student mobility in Ontario. With this in mind, ONCAT funds projects through an annual Request for Proposals (RFPs) in various areas of credit transfer, including Innovative Transfer, Pathway Development, and Research. This year we decided to automate the RFP application process through an online platform, after consultation with stakeholders.

Additionally, 35 new final reports for research and pathway development projects were posted to the ONCAT website; these are significant learning resources to the sector, serving to bring together examples, tools, and experiences on credit transfer and articulation. development of student mobility more broadly. Recognizing the exciting potential of these new opportunities, in 2016-17 ONCAT began offering an RFP with a focus on Innovative Transfer. This has included new models of academic collaboration and system-wide solutions to reduce barriers for transfer students, with 5 projects receiving funding in the 2017-18 year.

In addition to continuing to offer this new RFP, ONCAT has begun work on two projects that address the complexity and challenges in the areas of adult education and credential laddering and latticing*. The approaches hold promise in contributing to the accessibility of lifelong learning, and offer legitimate second-chance options for students who, for various reasons, seek to change programs, institutions, or credentials.

INNOVATIVE TRANSFER

As our understanding of credit transfer grows, so too do new ideas and perspectives on the application and

^{*} Laddering (or stacking) implies a linear approach to learning with students moving in one direction and typically through high affinity pathways, whereas latticing facilitates movement through a matrix of credentials, not necessarily in any one direction or only along high affinity pathways.

PATHWAY DEVELOPMENT

12 new pathway development projects were added to the previous 130 ONCAT has supported through the Credit Transfer Innovation Fund since 2011. These projects help in the development and implementation of strategies to enhance student mobility, expansion of transfer opportunities, and increases in postsecondary collaboration.

KNOWLEDGE GATHERING

Knowledge gathering develops more robust indicators of our success, both as an organization and a province, with respect to credit transfer, and helps us measure success against system-level

goals. ONCAT funds and engages in research projects that examine student experiences of transfer and patterns of academic performance. Some of the research we are leading and supporting:

- In the 2017-18 RFP process, a total of 6 research projects were funded.
- A redeveloped Student Experience Survey was launched in February 2018, administered through CCI Resources Inc, and distributed with support from the student organizations (CFS-ON, OUSA, CSA). The survey will help shed light on the experience of students prior to, during, and after the transfer process, as well their experience interacting with the ONTransfer.ca website. To date, we have received over 4500 responses, and in early 2018 an analysis will be run on the result.
- The Ontario College & University Transfer
 Analysis, in partnership with the Ontario College
 Application Service (OCAS), looks at student
 patterns using transcript transfer requests from
 OCAS and OUAC (the Ontario Universities'
 Application Centre) for three population groups (all
 students, first generation students, and indigenous

students), mapped along region, college/ university, and area of study.

 Trends in Student Mobility Research and Practice (formerly called Promising Practices) was completed, which reviewed of all of ONCAT's funded projects since 2011, and summarized the trends and insights found.





GROUPS



Faculty Fellows

Faculty play an essential role in the student experience of transfer. In 2016-17, ONCAT piloted a Faculty Fellows program to directly engage faculty in areas of student mobility and transfer. The five pilot institutions are La Cité collégiale, Université de Hearst, Lakehead University, Seneca College, and St. Clair College. Institutional project activities include Lunch and Learns, faculty focus groups and surveys, and reviews of transfer student data and transfer agreements.

Francophone and Bilingual Institutions Advisory Board

A working group of member representatives from francophone and bilingual institutions, to better understand and address the particular contexts and challenges of those institutions. Comprised of 9 public francophone or bilingual institutions in Ontario, including affiliated or confederated institutions: Collège Boréal, Collège Universitaire Dominicain,

Collège Universitaire Glendon, La Cité collégiale, Université de Hearst, Université Laurentienne, Université d'Ottawa, Université Saint Paul, Université de Sudbury.

Learning Outcomes Steering Committee

A working group of member representatives who are developing a better understanding of the role of learning outcomes in the credit transfer process and how they can improve existing and future pathways. As part of this work, ONCAT's multi-year "The Learning Outcomes for Transfer - Publication Project" aims to assess critically the theoretical and conceptual foundations, assumptions, and implications of using learning outcomes for the purposes of credit transfer and student mobility. An international, large-scale assessment of outcomes-based approaches has been conducted, from which preliminary implications and recommendations for the Ontario context have been composed.

Northern Institutions' Pathways Steering Committee

A working group of member representatives from northern institutions, to better understand and address the particular contexts and challenges of institutions based in the north. The Steering Committee includes four

improve collaboration across the institutions and to provide students with unique educational opportunities in Northern Ontario.

Student Advisory Board

Comprised of students, the board provides advice on the on-going operational activities of ONCAT, and advises on the development of new ideas and initiatives to enhance and support student mobility, including credit transfer information products.

Transfer Advisor Group (TAG)

Transfer advisors, at both sending and receiving institutions, are often times students' first official point of information when making decisions about transfer. Established to provide feedback and guidance, TAG provides ONCAT with sectorwide expert advice on transfer advising. The first TAG meeting was held in 2017, with participation from 37 attendees from 34 institutions.

In March 2018 the second successful meeting saw the election of the co-chairs, and the development of first year objectives.



Transfer Committees

Comprised of representatives from a specific discipline (English, History, Engineering, Game Education, or Business), drawn from the colleges and universities that offer at least one credential in that field of study. They act as a platform for information sharing and discussion on student mobility in the discipline. Industry and accreditation bodies also participate in committees when relevant. such as within the Engineering Transfer Committee. This past year the formation of two new transfer committees began, in the areas of Community Services and Biology/ Biotech.
